### **1.Selection for “The Sustainability Yearbook 2025”**

S&P Global assesses the sustainability performance of the world's leading companies from economic, environmental, and social perspectives, and selects the top 15 percent of companies in each industry annually as Yearbook Members to include in “The Sustainability Yearbook.”

In the 2025 edition, 780 companies have been named out of over 7,690 companies in 62 industries. Sompo Holdings recognized particularly high marks for Materiality, Climate Strategy, Human Rights, and Human Capital.

### **2.Sustainability Initiatives of the Sompo Group**

The Sompo Group is one of the first financial institutions in Japan to establish a Global Environment Office after its participation in the Rio de Janeiro Earth Summit held in Brazil in 1992, and has been a pioneer in sustainability initiatives, including the continuous holding of "Public Seminars on the Environment" in collaboration with environmental NPOs since 1993. We have been developing pioneering sustainability initiatives. These efforts are also linked to communication with stakeholders by disclosing information through responses to sustainability assessments. In recognition of these efforts over the years, the 25th anniversary trophy for participation in the CSA (Corporate Sustainability Assessment) was awarded at the awards ceremony on April 8.

In addition, Sompo Holdings has evaluated as the highest "AAA" rating in the ESG ratings by the U.S. rating company MSCI, and has also been selected as an "A List" company, the highest rating in the 2024 "CDP Climate Change", an international non-profit organization. (Sompo has been selected eight times in total since 2017.)

### **3.Outlook**

The Sompo Group is committed to creating economic value and social value by solving social issues through its core businesses, with the Sompo Purpose, which is expressed as “For a future of health, wellbeing and financial protection”.
